

NOTICE OF FILING LABOR CONDITION APPLICATION

Under Section 20 C.F.R. 655.734(ii), the Department of Labor requires that where there is no collective bargaining representative, the employer shall, on or within 30 days before the date the LCA is filed with ETA, provide a notice of the filing of the LCA.
